





Risk Management Policies

- Requires Management Committee approval for any lawyer to act as director, officer or trustee of any corporation or other organization and specifies information to be provided to the Management Committee in seeking approval and the application of directors’ fees and the other emoluments arising from the position.

Affidavits

- Specifies appropriate procedure for execution of affidavits as commissioner for oaths.

Anti-Corruption

- Policy to ensure that firm personnel do not engage or condone corrupt practices and are aware of applicable anti-bribery and anti-corruption laws.

Anti-Trust/Competition

- The Firm and all its personnel are instructed at all times to comply with all applicable competition laws. As a practical matter, the key provisions of Canadian and U.S. competition laws applicable to the Firm are prohibitions on anti-competitive agreements between competitors.

Asset Searches

- Outlines practices and procedures re: asset searches.

Auditors’ Response Letters

- Specifies procedures for responding to auditors’ letters by the Firm on behalf of its clients.

Cheques

- Establishes procedures for approving cheque requisitions and signing cheques.

Client Identification/Verification

- The Toronto and Montreal offices have client verification and identification procedures as required by the Law Society of Ontario and the Barreau du Québec.

Confidential Materials

- Specifies procedures for shredding and disposing of confidential materials.

Confidentiality and Securities Trading

- Outlines legal obligations of partners and employees of the Firm re: confidential information and insider trading and sets out appropriate procedures and practices to be followed in respect of dealing with confidential information and restricted securities.

Conflicts

- Specifies procedures for conflict checks when opening all new files and, where appropriate, provides for establishing of “ethical walls” in accordance with applicable laws and law society guidelines.

Dealing with the Press

- Specifies guidelines for dealing with press inquiries re: clients or transactions.

E-Mail

- Establishes standards for e-mail usage and storage of email records.

Fees and Accounts

- Outlines legal requirements and internal procedures re: docketing, fees, disbursements, billing practices and accounts.

Guidelines and Procedures for Ethical Walls and Restricted Access Matters

- Provides information as to the purpose and types of ethical walls and matters that are required to be maintained on a restricted access basis and sets out procedures for establishing and updating same.

Information Security and Technology Policy

- Sets out information and requirements for all members of the Firm relating to access to, and use of, confidential information, Firm technology and the Firm’s computer network.

Management of Client Records

- Outlines procedures for how documents should be dealt with throughout the course, and at the end, of a matter, the management/destruction of paper copies and the maintenance of electronic versions.

Mentor Program

- Establishes mentor program for junior lawyer and students to enhance professional development, to supervise work and to provide advice, coaching, training and feedback.

Opening a File

- A conflict search is conducted on all new clients as well as on the reopening of previously closed files. All new clients are reviewed and accepted by an equity partner. If a non-equity partner wishes to bring in a new client, the acceptance of this new client would be brought to the attention of the practice group leader who is an equity partner and who would make the final decision. A new client or a new matter form is opened for each new client or new matter for an existing client which sets out pertinent information relating to the client or matter including key words for use in subsequent conflict check.

Opinions

- Establishes opinions committee to prepare standard form opinions for the Firm and sets out procedures for review and approval of all Firm opinions.

Outside Counsel

- Specifies procedures when retaining or being retained as outside counsel; provides for maintenance of list of approved local counsel in other jurisdictions

Retention and Disposal of Client Files

- A policy for the disposal of client files was approved by the Management Committee driven by the *Limitation Act*, 2002 (Ontario) and taking into consideration the different limitation periods for our Montreal and New York offices. Real Property Title Searches, Estate Planning Matters, Clients Who are Minors or Incapacitated, Record Books and Adoption Records will be retained for an indefinite period.

Substance Misuse

- Outlines prohibited activities re: illicit drugs and alcohol and the consequences of breach of policy and identifies Firm support program for persons with substance- related problems.

Terms and Conditions Governing Ethical Walls and Restricted Access Matters

- Sets out the terms and conditions with which Firm members must comply when given access to matters which are subject to an ethical wall or maintained on a restricted access basis.

Trust Accounts

- Outlines legal requirements re: trust accounts.

Work Sharing

- Specifies practices relating to appropriate staffing of matters or transactions.

In 2007 and 2015, the Firm underwent a comprehensive risk management audit conducted by John L. Walker, Barrister and Solicitor (now Walker Sorenson LLP) which involved a review of the risk management policies and procedures of all the Firm's offices.

In 2013, the Firm rolled out the CLLAS E-Learning program, a risk management practice available to all lawyers and other professionals in all offices of the Firm.

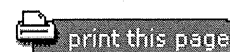
